Motion carried.

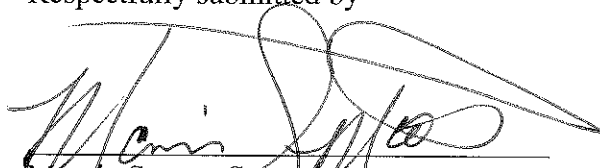
G. Adjournment
